Your request for participation will be given consideration by the Festival committee on the basis of the following: 1) space availability, 2) craft or exhibit type as to Festival needs, and 3) your craft's appropriateness to a farm heritage theme. Our Committee will notify you of a decision by at least May 20, 2010.

The Bob Evans Farm Festival is a country, "Down on the Farm" type of Festival -- we do not permit carnival-type or commercial items. We make every effort to have displays and working crafts, which best represent the traditional ways of country living our forefathers practiced so many years ago. Quality crafts, creative booth displays and demonstrations have made our Festival most successful over the years.

If you are accepted into our Festival, you will be required to pay a booth space fee of \$170.00 however we do not require a commission on sales. **Do not send your booth fee at this time.** You will be contacted at a later date if you are accepted and we will require the payment then. Our booth spaces are approximately 12' x 12' in size and are located in large tents of various sizes.

We will look forward to receiving your completed "Request for Participation" form along with your photos. Thank you for your interest.
